- You may register up to three (3) Unifi Air Biz 5G line at TMpoint however, if you would like to request more or already have three (3) existing unifi Air lines, Kindly Submit your next application to TM SME sales consultant for processing.
- Eligible applicants are required to bring valid documentations and other company details as below:
 - o Photocopy of company director/authorised signatory's NRIC
 (both sides) / Passport (for Non-Malaysians)



- o If you're an existing TM customer, please bring along your latest bill that is registered under your company name/Business Registration Number (BRN).
- o Company Authorisation Letter for non-director authorised signatory
- o Original or certified true copy of certified documents (whichever applicable)

- Upon successfull registration, You will receive one (1) set of 5G wireless router (power adaptor, LAN cable & Quick guide start) ("Equipment") & one (1) unit Unifi Air 5G sim card.
- You are required to pay RM149 as upfront payment for registration or RM300 if you are a non Malaysian.

4. CONTRACT PERIOD

- Upon successful registration, you will be bound with a minimum subscription period of 24 months contract ("Minumum Subscription Period").
- You may opt to terminate the service within the Minimum Subscription Period and be exluded from early termination fee if:-
 - I. Proven the 5G network experience based on registered service address is very bad or congested.
 - II. Proven wrong information from our customer service or reseller or agent.
 - III. Proven there is an element of fraud from our customer service or reseller or agent.
- However if the Unifi Air 5G Service is terminated before expiry of the Minimum Subscription Period, You will incur an early termination fee, which will be calculated based on the remaining balance and will be included in your final bill.



Formula:

 $[RM1,300* \div 24 \text{ months}] \times [Remaining month(s] = [total penalty]$

*Base Penalty: RM1,300.00

Example:

Early termination penalty calculation for Unifi Air 5G Service with 5 months remaining contract.

 $[RM54.20] \times [5 months] = [RM271]$
