 - Free calls to TM fixed line (Local) and TM fixed line (National).
- iii. unifi biz 30Mbps™
- Simple Voice Plus 50 consists of free calls up to RM50 monthly for local and national calls (for Fixed and Mobile lines).
 - Beyond calls rates will be charged calls to Mobile and other providers' Fixed line at 12sen/minute.
 - Free calls to TM fixed line (Local) and TM fixed line (National).
- iv. unifi biz 10Mbps™
- Simple Voice Plus 30 consists of free calls up to RM30 monthly for local and national calls (for Fixed and Mobile lines).
