 - h) In "Product licenses" page, check option of "Assign user a product license" and Tick at "Micrososft Team Commercial Cloud"
 - i) System will display "Review and Finish" page for any editing
 - j) Click "Finish Adding"
 - k) System will display "A B added to active users"
 - I) Click "Close"
 - m) System will display "Active users" page
- 3.2 Customer is advised to proceed log-in to <u>Microsoft Admin Center</u> for any post license activation services such as addition or removal of users in the organization, change licenses, reset password and etc.
- 3.3 For any after sales support with regards to the Service, Customer is advised to contact TM Contact Centre. In special circumstances, TM Contact Centre will escalate Customer issues and/or complaints to Ingram Micro for technical support.
